WAIVER OF LIABILITY AND RELEASE

This form must be completed and signed by each soccer player or other Club program participant. If the player or participant is under 18-years old, this form must be signed by the player's parent or legal guardian. No player, or other Club program participant will be allowed to participate Club or league activities or tournament games without this form, properly executed, and on file with the Club.

I, the undersigned, in consideration for my voluntary participation in organized soccer, do hereby acknowledge that my signature below attests to my understanding and agreement that:

1. My player status will be kept in good standing. I will not compromise myself in such a way as to do harm to the league or tournament, knowing that players may be dismissed from participation, with possible loss of payment or dues, for violent conduct or unsportsmanlike behavior on or off the field of play. I agree to pay for any and all damages to any property or persons caused by me willfully, negligently, or otherwise.

2. Soccer is a physical, contact, sport that involves an inherent risk of injury. I assume all risks and hazards associated with my participation in the sport. I am in proper physical condition to participate in soccer practices and games and have no illness, disease or existing injury or physical defect that would be aggravated by my participation. I will inform my coach if this status changes. I further acknowledge that this risk may involve loss or damage to me or my property, including the risk of death, or other unforeseen consequences, including those which may be due to the unavailability of immediate emergency medical care. I have a current medical consent form in force. I will wear shin guards, properly fitted and appropriate shoes, and other protective equipment (e.g., mouthpieces), as provided by soccer rules, to all events.

3. NWI Eagles, the league, and the organizers of any tournament in which I participate do not maintain personal injury or health insurance which provides coverage for me. For this reason, I will maintain current, active, personal injury and health insurance policies in force, which would provide coverage for any injuries caused, or health care necessitated, by my participation. Under any condition, I am responsible for any and all medical expenses arising from my participation, both in practices and games and while travelling to and from these events. I have the right and responsibility to inspect the equipment and facilities prior to events and, if I believe that anything may be unsafe, I will advise the coach or supervisor of the condition and may refuse to participate. Participation assumes consent.

4. I hereby authorize my photograph, picture or likeness, and voice to appear in any documentary, promotion (including advertising), print, television, website, video, or radio account relating to NWI Eagles FC, the league, or any tournament, without compensation, and fully release and hold harmless NWI Eagles FC, the league, or any tournament, their managers, employees, owners, agents and representatives from all claims arising wholly or in part from any use of my photograph, picture, likeness or voice, in any medium, for any purpose.

5. I authorize that an unaltered copy of this form may be generated and given to the officers or directors of other leagues or tournaments to allow my participation in their soccer programs, if the form is required and I have requested to participate.

6. In exchange for the opportunity to participate in activities organized, attended or sponsored by NWI Eagles FC, I hereby remise, release, and forever discharge NWI Eagles FC, LLC, as well as its members, managers, employees, agents, successors, representatives, volunteers, and attorneys, from any and all liability, claims, counterclaims, causes of action, suits, debts, sums of money, accounts, controversies, damages and demands whatsoever, whether currently known or unknown, accrued or contingent, at law or in equity, which I may now have, or hereafter may have, by reason of any matter, event, or occurrence relating in any way to my participation in such activities.

7. In addition, I hereby agree to indemnify and hold harmless, indemnify, and covenant not to sue, NWI Eagles FC, LLC, as well as its members, managers, employees, agents, successors, representatives, volunteers, and attorneys, with respect to any item of damage or expense incurred by them in connection with any of the matters released or discharged in the immediately preceding paragraph 8 of this

agreement, including but not limited to any reasonable attorney's fees or litigation expenses (including expert fees) incurred by the indemnified parties.

8. I also release and forever discharge the United States Soccer Federation, the State Association, the league and all tournament organizations, their associated directors, administrators, officers, managers, employees, coaches, trainers, volunteers, sponsors and advertisers, and other agents, as well as their members, managers, employees, agents, successors, representatives, volunteers, and attorneys, from any and all liability, claims, counterclaims, causes of action, suits, debts, sums of money, accounts, controversies, damages and demands whatsoever, whether currently known or unknown, accrued or contingent, at law or in equity, which I may now have, or hereafter may have, by reason of any matter, event, or occurrence relating in any way to my participation in activities sponsored by these entities or persons.

9. I have reviewed this document carefully, have been given an opportunity to discuss it with my counsel, and fully understand its contents. I acknowledge that I have given up substantial rights by subscribing to this agreement and state that I do so voluntarily. My signature attests to this on behalf of myself and my executors, personal representatives, administrators, heirs, next-of-kin, successors, and assigns.
